2. **Implementation of COVID-19 SOPs.** Members are requested to instruct their boat staff (boat driver/ tindal) and boat repair technicians to carry COVID-19 vaccination card while visiting DA Marina Club. Entry without COVID-19 vaccination card is restricted in the Club.
3. **Correspondence with Club.** It has been observed that correspondence with Club is being made with the signature of representative of members, which is contrary to Club Rules. Member can only correspond with Club and even household members are not allowed. Members are, therefore, requested to send letters/ e-mails with their signatures or through their e-mail IDs.
4. **Updation of Data.** Members are requested to update their record with Club to include contact no, e-mail addresses, addition/ deletion of family members due to birth, marriage, death etc.
5. **Boxes/ Lockers.** It has been observed that large number of boxes, lockers etc are lying haphazardly in Club's Boat Parking Area. These boxes/ lockers are being used by members (boat owners) as store. Executive Committee in its meeting held on 8 Jun 2021 approved levy of hard rent on more than one Tool Box occupying space in Boat Parking Area at prevailing rate wef 1 Jul 2021. Members are, therefore, once again reminded to remove additional boxes/ lockers to avoid levy of hard rent.
6. **Parking of Boats above 40 ft on Mooring.** Due to induction of new members no of boats parked on land in DAMC has increased. Furthermore, with the execution of new projects, it has become very difficult to manage parking of boat due to paucity of space in Boat Parking Area. Members are, therefore, requested to shift their boats above 40 ft to mooring at sea.
7. **Independent Membership for Ex Household Members.** Ex household members of the Club have a privilege to become independent Regular Members of DA Marina Club on subsidized rates. Interested members who want to avail this opportunity, may contact Club administration so that their independent Regular Membership may be processed in the forthcoming Executive Committee Meeting (ECM) scheduled on 26 Aug 2021.
