**INSTRUCTION SLIP**

1. To apply for Revocation of General Power Attorney following documents are required to be submitted:-
  - a. Covering letter requesting for revocation of GPA.
  - b. Revocation Deed Original Copy. (Specimen attached)
  - c. 1 x CNIC each duly attested.
  - d. Return both copies of acceptance letter of GPA (Owner/Attorney issued by this office).
  - e. Owner DHA valid Membership Card/Renewal Receipt copy required.
2. Once the application for general power attorney has been accepted please pay the fee in the Accts Branch (1<sup>st</sup> floor). The Accts Branch will make the necessary endorsement on the covering letter.
3. The applicant to deposit the application at the Reception (veranda) and obtain a receipt. The receipt will indicate the date of collection.

1. All dues must be cleared before submission.
2. All fees are subject to change without notice.
3. Before making out a Pay order/Bank Draft please find out the outstanding dues and current rate of Fee from Accounts Branch.
