



## **DEFENCE AUTHORITY MARINA CLUB** **NEWS BULLETIN – FEBRUARY 2025**

1. **Monthly Bills.** It is intimated that effective from 1 Mar 2025, credit chits/ slips will be handed over at the spot i.e. point of sale, instead of sending along with monthly bill, only bill statement of members containing/ reflecting detail of credit chits/ slips will be sent. However, in case of any clarification/ verification duplicate chits/ slips can be obtained within a month subject to written request.
2. **Renewal of Membership Cards.** Members, whose membership cards have expired on or before 31 Dec 2024, are requested to get their cards renewed to avoid inconvenience while visiting Club as expired card holders are not accepted to utilize club facilities. Supervisory staff may request members and their household members to show cards to ensure exclusive use of Club facilities by members only.
3. **Renewal of Tindal Cards.** Tindal's card expired on 31 Dec 2024 must be renewed accordingly.
4. **Permanent Membership.** After completion of 5 years of "Regular" membership a member may apply for permanent membership after depositing requisite fee after fulfilling certain conditions. A permanent member is entitled for certain advantages like eligibility for selection as a member of Club's Executive Committee and privilege to "Propose" or "Second" candidates for membership of DAMC. Regular Members vying for Permanent Membership may apply in an early timeframe so that the cases can be processed in forthcoming Club Executive Committee Meeting.
5. **Transfer of Membership to Son/ Daughter.** Permanent Senior Citizen members have a privilege to transfer their membership to their son/ daughter. Members vying to transfer their membership contact Club administration so that their requests for transfer of membership may be processed in the forthcoming Executive Committee Meeting (ECM).
6. **Expiry of Household Membership.** On attaining the prescribed age limit (28 years for male and 30 years for female) or getting married, Household Membership Card is required to be returned to the Club office. In case of non compliance an amount of Rs 4,000/- per month will be charged till the return of Club Card. All those members whose wards have either got married or crossed age limit are requested to return their household membership cards whether valid or expired, as early as possible to avoid levy of charges.
7. **Iftar Cum Dinner (Package).** During Ramazan, Iftar cum Dinner (package deals) have been introduced at DA Marina Club. An elaborate and differing menu for each day of the week has been formulated and will be served at Newly Renovated Village Area, Club's Party Boats and on members' boats (parcel). Detail is attached.
